The Volunteer does hereby freely, voluntarily, and without duress execute this Release under the
following terms:
1. Waiver and Release . Volunteer does hereby release and forever discharge and hold harmless
Habitat and its successors and assigns from any and all liability, claims and demands of whatever
kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's participation in Habitat's homebuilding program.
Volunteer understands that this release discharges Habitat from any liability or claim that the
Volunteer may have against Habitat with respect to any bodily injury, personal injury, illness,
death, or property damage that may result from Volunteer's participation in Habitat's
homebuilding program. Volunteer also understands that Habitat does not assume any
responsibility for, or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance.
2. Medical treatment. Volunteer does hereby release and forever discharge Habitat from any claim
whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service
rendered in connection with the Volunteer's participation in Habitat's homebuilding program.
3. Assumption of Risk. Volunteer hereby expressly and specifically assumes the risk of injury or
harm in these activities and releases Habitat from all liability for injury, illness, death, or property damage resulting from activities of the Volunteer's participation in Habitat's homebuilding
program.
4. Insurance. The Volunteer understands that Habitat does not carry or maintain health, medical, or
disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to
arrive with medical or health coverage in effect.
5. Photographic Release. Volunteer does hereby grant and convey unto Habitat all right, title, and
interest in any and all photographic images and video or audio recordings made by Habitat during
