in favor of Habitat for Humanity International, Inc., a non-profit corporation, and Southeastern New Hampshire Habitat for Humanity, Inc., a New Hampshire non-profit corporation, their directors, officers, employees, volunteers, and agents (collectively "Habitat"). The Volunteer desires to work (the "Activities"). The Volunteer understands that the Activities may include construction and rehabilitating residential buildings, working in Habitat offices and living in housing provided for Volunteers of Habitat.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms.

**Release and Waiver**: Volunteer does herby release and forever discharge and hold harmless Habitat and its successors and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Habitat. Volunteer understands that this Release discharges Habitat from any liability or claim that the Volunteer may have against Habitat with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with Habitat, whether caused by negligence of Habitat or its officers, directors, employees, or agents or otherwise. Volunteer also understands that Habitat does not assume any responsibility for or obligation of financial assistance or other assistance, including but not limited to medical, health, of disability insurance in the event of injury or illness.

**Medical Treatment**: Volunteer does hereby release and forever discharge Habitat from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Habitat.

**Assumptions of the Risk**: Volunteer understands that the Activities include work that may be hazardous to the Volunteer, including, but not limited to, construction, loading and unloading, and transportation to and from the worksites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Habitat from all liability for injury, illness, death, or property damage resulting from the Activities.

**Insurance**: The Volunteer understands that, except as otherwise agreed to by Habitat in writing; Habitat does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical insurance coverage.

**Photographic Release**: Volunteer does hereby grant and covey unto Habitat all right, title, and interest in any and all photographic images and video or audio recordings made by Habitat during the Volunteer's Activities with Habitat, including but not limited to, and royalties, proceeds, or other benefits derived from such photographs or recordings.

**Other**: Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of New Hampshire, and that this Release shall be governed by and interpreted in accordance with the laws of the State of New Hampshire. The Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the validity of such clause or provision shall not otherwise affect the remaining provisions on this Release which shall continue enforceable.
